I - LINES OF RESEARCH

International policies, systems, and institutions of global health and sustainable environment

It is aimed to analyze the dynamics of globalization processes in relation to policies, systems, and institutions related to health and sustainable environment, with emphasis on the new functions of the state, international systems of social protection, international social movements, and transformations in demographic profiles. It also aims to conduct critical studies on international relations and agreements, diplomacy, and external health and environment agreements, aiming at health, nutrition, food and environmental security. It focuses on the international normative framework, international agreements, technological innovations and their local and global implications.

Sustainability and Ways of Life

It is aimed, using a critical and interdisciplinary perspective, to analyze social issues and processes in the interfaces and articulations between environment, constructed territories, society and health. It is focused on the following topics: technological innovations and adaptation to different international contexts; human displacement; global and local politics and their relations with social and technological risks; consumption and construction of subjectivities; scientific production and communication. It is also focused on studies of natural and technological disasters, environmental and health impacts and appropriate technologies for remediation in different contexts; urban experiences and adaptive reconstructions.

II - ENROLLMENT

2.1 - Period

Applications may be submitted from **April 08th to May 20th, 2024**.

2.2 Enrollment requirements

Applications will be received exclusively through the system available at the link <http://www.fsp.usp.br/inscricoes/login>. The candidate must fill out the form with his/her personal data, enter the required documents into the system, generate the bank payment slip for the amount of R\$200.00 (two hundred Brazilian reais - BRL), and pay the registration fee at any bank agency. Only registrations with payment will be approved. Once the registration and respective payment have been deposited, requests for a refund of the amount will not be accepted. The following documentation will be required:

- Copy of updated Curriculum Lattes (www.cnpq.br/lattes)
- Research project compatible with the Program area, indicating one of its research lines, obligatorily elaborated according to item 3.2.2.1, under penalty of disqualification from the competition (below)
- Letter of intent explaining the reasons that lead you to apply to this program
- Letter of recommendation from a professor or institution, preferably with information detailing the candidate's academic performance

2.3 Exemption from payment of the registration fee

Candidates who meet the conditions set forth in Sao Paulo State Law 12.782, of December 20, 2007, should apply for an exemption from paying the registration fee, according to the following procedures:

- **Between 10 a.m. on April 08th and 11:59 p.m. on April 12nd, 2024**, access the registration link for the selection process <http://www.fsp.usp.br/inscricoes/login> and correctly fill out the data requested for exemption;



● Insert in a single file, a letter addressed to the Coordination of the Graduate Program in Global Health and Sustainability (pdf) signed by the candidate requesting the exemption, with justification based on Sao Paulo State Law 12.782, of December 20, 2007, in addition to the following documents:

- a) copy of a certificate or declaration issued by a public or private educational institution, proving your status as a student; or
 - a1) copy of the student ID card or similar document, issued by a public or private educational institution or student representation entity; and
 - b) proof of income specifying that the candidate receives a monthly remuneration lower than 02 (two) minimum wages: or
 - b1) written statement of being unemployed.

Copies of documents sent by other electronic means will not be considered.

The Graduate Program in Global Health and Sustainability will publish on its website (<http://www.fsp.usp.br/pos/programas/saude-global-e-sustentabilidade/>), on **April 22nd, 2024**, the list of candidates whose requests have been granted. Candidates who have their exemption request accepted should access the selective process link: (<http://www.fsp.usp.br/inscricoes/login>) and proceed with the registration. For these cases, no payment slip will be generated. The candidate whose request is denied must access the selective process link: <http://www.fsp.usp.br/inscricoes/login> and proceed to complete the registration, printing and paying the bank slip, with the full registration fee, by the due date. The candidate who requests exemption and has his/her request granted or denied and does not complete his registration will not be considered registered for the selection process.

III - SELECTION PROCESS

The selection process will be composed of two phases, the first being eliminatory and the second qualifying, with the number of available openings determined by the availability of the advisors.



3.1 First Phase

The first phase of the exam (eliminary), held by the Program Coordinating Committee, will consist of a written test on basic knowledge in the area of Global Health and Sustainability.

The written test will consist of two essay questions that can be answered in Portuguese, Spanish, or English, with the purpose of testing the candidates' writing ability - taking as criteria the following: clarity, logical reasoning, critical sense, problem solving capacity, and objectivity - as well as their level of knowledge about the following texts:

The written test will be held remotely on **May 28th, 2024, at 9 am**. Candidates will receive by email the detailed technical instructions for the test. Even if the aforementioned date is later converted into a holiday, either national or in the Municipality or State of São Paulo, the test will be held on the same date.

The Coordinating Commission will set up a specific committee to correct the written test, to be constituted after the closing of the registration period. The evaluation of the written test will result in the categories: "Pass" or "Fail", with no concept or grade being assigned. Rejection must be justified by the coordinating committee, based on the criteria listed above.

Candidates qualified for the second phase will be notified of their qualification on **June 05th, 2024** by e-mail and on the FSP-USP Graduate Studies website (<http://www.fsp.usp.br/pos/programas/saude-global-e-sustentabilidade/>).



3.2 Second phase

The second phase consists of three stages: analysis of the Lattes CV (weight 3), analysis of the research project (weight 4) and discussion (weight 3), described below. At this phase the candidate must achieve a minimum score of 7 (seven) out of 10 (ten) for admission into the program.

3.2.1 The analysis of the Lattes CV will have as evaluation criteria the candidate's education, scientific and/or technical production and experience, especially regarding the themes of global health and sustainability (Weight 3).

3.2.2 The analysis of the research project - which must be elaborated according to the requirements described below in item 3.2.2.1 - will have as evaluation criteria the consistency of the proposal, the mastery of the research topic and the adherence to the field of Global Health and Sustainability; applications that do not include international and national literature on Global Health and Sustainability in their projects will be eliminated (Weight 4).

3.2.2.1 Requirements for the presentation of the research project

The project must have a maximum of 22 pages (including references) and may be written in Portuguese, Spanish, or English. It is also mandatory that it complies with the following script:

- a) Identification of the line of research;
- b) Abstract (maximum of 15 lines);
- c) Introduction and justification, with referenced bibliography, **being indispensable the use of academic literature from the field of global health and sustainability;**
- d) Research objectives
- e) Methodology, work plan, and execution timetable;
- f) Relevance and expected results of the research to the field of Global Health and Sustainability;
- g) Bibliographical references.

3.2.3 The exam will be conducted as per item 3.2.3.1 by a committee made up of two accredited professors in the program, selected by the Coordination as potential advisors, in order to assess: the mastery of the project presented, the capacity for oral



communication and availability for curricular completion, thesis preparation, and participation in the program's academic life, in addition to clearing up any doubts on the résumé, the project, and the letters of motivation and recommendation presented (weight 3).

3.2.3.1 The exams will be held via Skype or another available virtual platform, between **June 10th and 24th, 2024**. Candidates will be informed by email about the interview schedule by **June 07th, 2024**.

3.2.4 The Coordinating Commission will constitute a specific committee for the evaluation of curricula and projects.

c) RG or RNE (for foreigners) *. Documents from professional associations will not be accepted;

d) CPF;

e) Voter's Clearance Certificate (taken from the TSE website <http://www.tse.jus.br/>);

f) Birth or marriage certificate

g) Proof of clearance from the military service (only for Brazilian born or naturalized male Brazilians);

h) Graduation diploma**;

- i) Copy of the undergraduate academic transcripts
- j) Master's degree, with proof of accreditation of the Master's course with CAPES or from a foreign institution whose diploma is equivalent to or recognized by USP (except for Direct Doctorate);

- k) Copy of the academic record of the Master's course (except for Direct Doctorate);

*The admission of foreign candidates to the Program will be subject to compliance with the provisions of Article 42 of the Postgraduate Regulations of the University of São Paulo (www.leginf.usp.br/?resolucao=resolucao-no-6542-de-18-de-abril-de-2013) and specific requirements demanded by the USP Agency for National and International Academic Cooperation (www.usp.br/internationaloffice).
